

## Mexico Global Compact Companies Elect Two New Representatives in General Assembly

The Global Compact Mexico held its General Assembly on February 8, 2024, during which the results report for the year 2023 was presented and through a vote the representatives of the companies participating in the initiative elected two new members, appointing Grupo Herdez and Orbia on the Board of Directors.

The Assembly allows the participating companies to learn about issues relevant to the Local Network, while serving as an instrument of transparency in its operation. In its second edition, members of the governance committee made a call to action highlighting the importance of anti-corruption business practices.

"I am convinced that companies that join and take advantage of the Global Compact Mexico offer, strengthen their business model and reach a higher level of maturity in sustainability. Our promise is to increase the collective impact of companies by internalizing the Ten Principles of the Global Compact, enabling companies to meet the Sustainable Development Goals," said Carlos Mendieta Zerón, Chairman of the Board of Directors of Global Compact Mexico.

On the other hand, Mauricio Bonilla Padilla, Executive Director of Global Compact Mexico presented the summary of the 2023 results and added "We have had 655 new companies in the last 5 years, today there are already 824 participating companies. We are pleased and

motivated to have companies so committed to sustainability and I invite them to continue accelerating and amplifying actions in the face of global challenges through ambitious goals."
